This is with reference to the proposal submitted by R.J. College of Arts, Science & Commerce, Opp. Ralway Station, Mumbai-400 086 (Maharashtra) affiliated to University of Mumbai, Fort Mumbai-400 032 under the UGC Scheme for Autonomous Colleges.

I am directed to convey that the Commission at its meeting held on 24.05.2018 has decided to grant autonomous status to R.J. College of Arts, Science & Commerce, Opp. Ralway Station, Mumbai-400 086 (Maharashtra) affiliated to University of Mumbai, Fort Mumbai-400 032 for a period of ten years w.e.f. 2018-2019 to 2027-2028.
